ORDINANCE NO. 27

AN ORDINANCE AMENDING ORDINANCE NO. 17
ADDING SUBSECTION (e) TO ARTICLE IV, SECTION 4.02
RATES AND CHARGES FOR SECONDARY DWELLING UNITS

BE IT ORDAINED by the Board of Directors of the McKinleyville Community Services District, Humboldt County, California, as follows:

Subsection (e) shall be added to Article IV, Section 4.02 as follows:

(e) The connection charge for the addition of a secondary dwelling as defined by Humboldt County Ordinance No. 1633, Chapter 6.1 shall be the same as the local sewer availability charge for four - inch laterals as specified in Section 4.02, subsection (c)-2) above. If an additional lateral is required the full charge rate shall apply.
