ORDINANCE NO. 29

AN ORDINANCE OF THE  
MCKINLEYVILLE COMMUNITY  
SERVICES DISTRICT AMENDING  
ORDINANCE NO. 3

BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE  
MCKINLEYVILLE COMMUNITY SERVICES DISTRICT, AS FOLLOWS:

1. ORDINANCE NO. 7 passed and adopted by the Board of  
Directors on the 4th. day of December 1975, is hereby repealed.

2. ARTICLE 17 of ORDINANCE No. 3 is hereby Amended to  
read as follows:

"ARTICLE 17. RATES

270. Rate Schedule. Rates for water service are hereby  
established as follows: In the event of bi-monthly billings, the  
minimum charges shall be doubled and the quantity of water consumed  
shall be averaged:

MINIMUM CHARGES PER MONTH. (Includes water consumed to dollar  
amount listed, at consumption rates below)

5/8 x 3/4" meter	\$ 6.75
3/4" meter	7.65
1" meter	13.05
1-1/2" meter	30.60
2" meter	51.75
3" meter	92.25
4" meter	142.05
6" meter	192.15
8" meter	242.25

CONSUMPTION CHARGE RATES PER MONTH.

0 - 500 cubic feet	\$ 6.75
next 1500 cubic feet	0.90 per 100 cubic feet
next 8000 cubic feet	0.45 per 100 cubic feet
all over 10,000 cubic feet	0.30 per 100 cubic feet

3. This ordinance shall take effect on the first billing date of each customer account after January 1, 1985.


I, Wilmot F. Cooke, Secretary of the Board of Directors of McKinleyville Community Services District, do hereby certify as follows:


