The Forest Management Plan and Funding/Budget Subcommittee held meetings on December 3, 2024 and January 7, 2025. - Subcommittee discussed whether to review the Project ranking list from the TICS prior to brining it to the Full Committee and decided that since all members of the FMP Subcommittee will review as part of the Full Committee, there was no need to review and comment on it twice.
- We also discussed budgeting and other funding opportunities.

Recommendation:

Staff recommends that the Committee review this information provided, discuss, and take public comment on the potential establishment of a 501(c)3 Non-Profit.

Discussion:

The McKinleyville Community Forest (MCF) provides recreational, educational, and ecological benefits to our community. However, sustained funding and community engagement are critical for ensuring the forest's ongoing management and growth. Forming a 501(c)(3) nonprofit organization, "Friends of the McKinleyville Community Forest" (Friends of MCF), would create a dedicated entity to:

- Attract tax-deductible donations and grants.
- Coordinate and expand volunteer activities.
- Promote awareness of the forest's value.
- Serve as a partner organization to the McKinleyville Community Services District (MCSD) and other stakeholders.

Discussion Points:

- 1. Mission and Vision Statement:
 - What should the mission and vision of Friends of MCF encompass?
 - Alignment with MCF's goals.
- 2. Structure and Governance:
 - Proposed bylaws and governance model.
 - Initial board composition and recruitment strategy.
- 3. Partnership with MCSD:
 - How will the nonprofit interface with MCSD?
 - Possible Memorandum of Understanding (MOU).
- 4. Funding Opportunities:

- Identifying key grants and fundraising campaigns.
- Strategies for leveraging local businesses and philanthropic donors.
- 5. Community Engagement:
 - Engaging residents in the nonprofit's formation and activities.
 - Hosting kickoff events or informational sessions.
- 6. Legal and Financial Considerations:
 - Process and cost of filing for 501(c)(3) status.
 - Estimated operating budget for the first year.

Proposed Next Steps:

- 1. Convene a working group to:
 - Draft bylaws and other foundational documents.
 - Develop a detailed timeline for formation.
- 2. Reach out to potential board members and advisors.
- 3. Identify immediate funding needs and opportunities for seed funding.
- 4. Plan a public outreach strategy to introduce the concept to the community.

Recommendation:

Staff recommends that the Committee review the information provided, discuss, and take public comment on the CAL FIRE Forest Health and Forest Improvement Program grants.

Discussion:

As the Committee is aware, the District has been working with Green Diamond Resource Company (Green Diamond) and the Humboldt County Resource Conservation District (HCRCD) on the development of a California Vegetation Treatment Program (CalVTP) project for the Community Forest and the Green Diamond land to the east of the Community Forest. As discussed at previous meetings, the scope of the project is the creation of a shaded fuel break at the forest and community interface, and the thinning of vegetation throughout the forest. The draft Project Specific Analysis (PSA) and Addendum to the California Vegetation Treatment Program (CalVTP) Program EIR (PSA/Addendum) has been finalized. The draft PSA/Addendum went to the HCRCD for approval at their January 9th Board Meeting. MCSD will take the PSA to our Board for review and approval at the February 5, 2025 Board Meeting. The PSA can be reviewed on the District website at https://mckinleyvillecsd.ca.gov/news-and-project-updates. The PSA and the CALFIRE EIR can also be found at the State of California ceqanet website at https://ceqanet.opr.ca.gov/.

As also previously discussed, MCSD, in conjunction with HCRCD and Green Diamond are pursuing a CALFIRE Forest Health grant to fund the implementation of the proposed Vegetation Treatment Project. The grant was completed and submitted prior to the January 15th due date. The grant request is for \$5,198,815.42 and will fund measures on 3043 acres of Green Diamond and 598 acres of MCSD land. The work on MCSD land will focus on the establishment of the shaded fuel break on the northern and western boundaries of the Community Forest. There is no cost share requirement for the grant; however, the District will contribute Staff time toward the implementation of the project, estimated to be approximately \$5,000 worth of fully loaded effort. The project will not be implemented unless and until grant funds are procured. If the grant is funded, District Staff will reach out to the neighbors directly adjacent to the areas to be treated to further discuss the project and the timing of the work.

As the Committee is also aware, the District and Forest Management Plan Subcommittee are also working with BBW & Associates to complete a CAL FIRE California Forest Improvement Program (CFIP) grant application. If the grant is obtained, it will be used to help fund the completion of the Forest Management Plan. James Robbins, CALFIRE Forester, has been very helpful in the preparation of the grant application and has said that it "...will be submitted for our January batch." Unfortunately, we have run into a hitch. The County Assessor's Office has not completed the revisions to the Parcel Maps and County records for the Community Forest parcels. County records still show Green Diamond as the owners and have not been updated to show the new parcels and parcel numbers. The property transfer was completed in January 2024. Green Diamond, the District, and CALFIRE have been working to resolve this with the County and continue to urge them to update the data, to provide proof to CALFIRE that the District owns the land. Meanwhile CALFIRE local staff is also working to see if there are other measures that can take to satisfy the grant requirements. The Forest Management Plan Subcommittee will continue to head up the completion and possible implementation of this grant and will bring updates back to the MCFC.
